Requirements of subscriber:

- To join the **Standard Book Program** you (not just your whole firm) must order records from Med-Legal on at least two (2) cases per month
- For the **Premium Book Program**, which includes the AIR impairment rating program and eCases case management program, you (not just your whole firm) must order records on at least 5 cases per month.

Termination:

The subscriber may terminate the program at any time by simply calling, emailing, writing or faxing a notice to Med-Legal, Inc. stating that they no longer wish to participate. Med-Legal, Inc. may also terminate the agreement if the subscriber fails to provide the minimum number of copy service orders (consistent monthly orders on at least 2 cases per month for the Standard program, and 5 cases per month for the Premium program). Upon termination of this agreement the Subscriber must RETURN all of the books and materials that were provided under this agreement within 30 days. The license to use the website and the AIR and eCases programs will also be revoked and must be removed from all computer systems. If Subscriber fails to return all items and remove all programs from their system within 30 days of a Notice of Termination from Med-Legal, Inc. they must pay Med-Legal, Inc. for all non-returned items at the retail price listed on the getMedLegal.com website.
